To promote the general progress and well-being of individual students and of the Learning Mentor Group as a whole. To liaise with Learning Leaders to ensure the implementation of the school's Pastoral System. To register students, accompany them to assemblies, encourage their full attendance at all lessons and their participation in other aspects of school life. To evaluate and monitor the progress of students and keep up-to-date student records as may be required. To contribute to the preparation of Action Plans and progress files and other reports. To alert the appropriate staff to problems experienced by students and to make recommendations as to how these may be resolved. To communicate as appropriate, with the parents of students and with persons or bodies outside the school concerned with the welfare of individual students, after consultation with the appropriate staff To contribute to CPSHE and citizenship and enterprise according to school policy To apply the Behaviour management systems so that effective learning can take place.
